President's Message

7 Ways of Worry

I was a little nervous at Convention this year. We were bringing our document "7 Ways the Proposed Wisconsin Budget is Wrong for Women and Families" to share with the other branches. After I put out the call mid-March for help outlining the ways in which the WI budget proposals went against AAUW priorities, many members responded and six were able to meet: Ginny Jordan, Kim Wellnitz, Lois Helland, Sarah Harder, Mary Hayden, and Margot Bouchard. We worked together to plan, research, and wordsmith the resulting "7 Ways" (in this newsletter & available at

http://www.wrongforwisconsinwomen.org/).

I was prepared to be questioned: "Why seven? Why not eight?" Or "what about cuts to STEM funding." Or "you left out X & Y." I was worried the nonpartisanship of the document would be questioned.

Instead we were called "brave". Our branch was thanked for taking this on, our efforts were praised, and the only strong critique that I heard was that we hadn't brought enough copies. (We put up a link to a printable pdf on the website.)

Bad News, Slightly Higher Dues

We thought we had an extra year before state increased dues by \$3, but the state is going to need to raise them now in order to support the Wisconsin 2-Minute Activist. You should be receiving a paper ballot, with a pin number – you can vote by mail or online.


- April 15, 2011 Paper ballots personalized with member number and a pin number mailed to all members.

- June 17, 2011 Electronic voting period ends at 9 p.m. EST online or onsite at the convention.




Book Group

I grew up in central Minnesota and I am excited to back in the upper Midwest after having earned my B.A. from Winona State University (2002), my M.A. from Minnesota State University, Mankato (2004), and my Ph.D. in Communication Studies and Women's Studies Graduate Certificate from Bowling Green State University (2007).

I teach primarily in the Organizational Communication Emphasis in the Department of Communication and Journalism (CJ) and am affiliate-faculty in the Women's Studies Program (WMNS). Courses I have taught at UW-Eau Claire include CJ/WMNS 111 (Gender, Race, & Class-The Social Construction of Identity (First-Year Experience Course)), CJ 202 (Fundamentals of Speech (Online & Face-to-Face)), CJ 300 (Research Methods), CJ 307/507 (Small Group Communication), CJ/WMNS 317 (Women in the Mass Media), CJ 350/550 (Training and Human Resource Development), CJ 387/497 (Academic/Advanced Academic Apprentice)...

I have presented several conference papers at national and regional conferences, which have focused on work-life balance, gender in higher education, training and development, pedagogy, Generation NeXt, civic engagement, and technology in the classroom.



Women hold up Half the Sky



If you missed out on our March meeting discussion, please consider putting this book on your *to read* list. Action is the whole point of this amazing book. I was deeply moved by the individual narratives Kristof and WuDunn combined with research data which reveal gross gender inequality in their four focus areas: maternal mortality, human trafficking, sexual violence and routine daily gender discrimination. They suggest such pervasive indifference to women's human rights is "the paramount moral challenge" of the new millennium.

I did feel empowered by undertaking the few easy steps suggested in the "What you can do" conclusion. Please consider doing one or more yourself:

- Read the book, lend it to others and spread the word. Make sure
 the issues raised in Half the Sky are not minimized or relegated to
 "women's issues" in discussions with friends, family members and
 colleagues.
- Sponsor a woman or create a micro-financing relationship with an individual. Go to kiva.org, globalgiving.org or support organizations such as Woman to Woman International.
- Sign up for some real news about women and women's issues at www.womensenews.org
- Join the CARE Action Network at www.care.org highly recommended by Kristof and WuDunn
- **Speak out** in support of women's microfinance programs. Write your members of Congress and ask them to support the Global Resources and Opportunities for Women to Thrive (GROWTH) Act, (S.1425) which would enable women living in poverty around the world to start and develop businesses through enhanced microfinance services, including loans and related financial tools. It also supports efforts to help women realize their full economic potential, such as ensuring land and property rights, supporting economic education, skills training and advocacy programs.

The authors comment: "We wrote a book devoted to women in the developing world because if you want to fight poverty and extremism, you need to educate and empower women and bring them into the economy. A country can't grow and be stable if half the population is marginalized. Please join the conversation, because we all have a role to play." "Thank you," conclude Nicholas Kristof and Sheryl WuDunn.

"7 Ways the Proposed Wisconsin Budget is Wrong for Women and Their Families"

AAUW-Eau Claire branch representatives at the convention were very proud of the work done by the ad hoc committee on AAUW policy/Wisconsin budget. Our branch leader and writer extraordinaire, Kate Hinnant, crafted an impressive document out of the many resources contributed by the committee members. Other branches and state and national AAUW leaders applicated the creation of the paper and pledged to circulate it to other members and organizations.

Representative Penny Bernard Schaber, 57th Assembly District

There is nothing like sitting six feet from a woman from Appleton who is serving her second term in the Wisconsin Assembly. We listened to her discuss what that experience has been like since January, 2011, and how she feels we have seen a "breakdown of Wisconsin government," and a move "away from government for the collective good." Representative Schaber said her greatest concern is the shift of power and the oversight over state agencies, which has moved from the legislature to the executive branch. On a positive note, Representative Schaber rejoiced in the "engaged, involved electorate" and encouraged us to continue writing short, handwritten notes to our legislators, and to keep letters to the editors flooding our local newspapers.

Kathy Flores, Diversity Coordinator for the City of Appleton

Ms. Flores' topic was "Moving Beyond Tolerance to Embracing Diversity." I was so captivated by her presentation and message that I find that I have no notes on this session. If you ever get a chance to attend one of her workshops or presentations, by all means do so.



AAUW State Branch Exchange

It is always fun to see what creative programs branches have been working on, and get new fundraising ideas. Most impressive was a Milwaukee branch with a preponderance of older members who brought three enthusiastic younger members to the convention.

- 1. Low-income families face cuts to child-care support, making it harder for them to achieve economic security. Parents participating in WI Shares, whether through W-2 programs or unsubsidized work, face co-pays, waiting lists, and reduced reimbursement. AAUW supports quality affordable dependent care especially for women in poverty. [1]
- 2. Increased tuition will be a barrier to access at Wisconsin's public colleges and universities. Higher education, now "more a necessity and less a luxury," is a key to this state's economic development. The 2011-2013 budget ends the Wisconsin Covenant, a program implemented to make college affordable for Wisconsin families. [2]
- 3. The expansion of voucher programs in K-12 will divert public funds to private and religious schools. AAUW believes that quality public education is the foundation of a democratic society. Voucher programs have a poor track record of providing educational outcomes, and siphon money to schools not required to meet public school standards of accountability and access. [3]
- 4. Deep cuts in funding for Wisconsin's technical colleges will reduce access to vocational training as more adults retool for jobs. Because of existing tuition formulas, these cuts mean cutbacks in staff, classes, and programs. AAUW supports greater access to technical colleges. [4]
- 5. Cuts to BadgerCare, the Title V Family Planning Program, sexual assault victim services, and the repeal of the Wisconsin Contraceptive Equity law will put the health of Wisconsin women at risk. Preventative care costs, including cervical and breast cancer screening, will be prohibitive for low-income women and families depending on these services. [5]
- 6. The well being of the most economically disadvantaged is threatened. Low-income working women face decreases in their Earned Income Tax Credit (EITC) and cuts in Wisconsin Works' (W-2) income support. Low-income senior citizens must move from SeniorCare's prescription plan to more costly Medicare D. And enrollment in the Family Care program has been frozen. AAUW believes in strengthening programs that allow women to achieve economic self-sufficiency and security. [6]
- 7. Women will be disproportionately affected by the termination of collective bargaining rights for public workers. Public sector unions have majority female memberships. Collective bargaining gives women and minorities a voice in workplace and leave benefits, crucial for women who shoulder the majority of childcare and eldercare responsibilities. [7]
