Presidents' Message

It's been over a decade since Matthew Shepard was viciously attacked and left for dead. I remember the collective shock and horror at the loss of a young man, college student, by all accounts sweet, and openly gay. I also remember, as a nation wrestled with the questions "how could this happen?" and "why?," others saying "hey, it almost happened to me, too" and "what do you think we live with everyday?" And so it happened that this 21-year-old man, who had been physically attacked because of his sexuality more than once in his short life, became the representative of a chorus of experiences across the nation.

It took awhile, but a federal legislative response to Shepard's death has finally passed both chambers of Congress. The Matthew Shepard Hate Crime Prevention Act strengthens current law that allows federal prosecution for crimes motivated by race, religion, or ethnicity. The Shepard Act widens the definition of biasmotivated crimes to include gender, sexual orientation, and disability. This classification has repercussions at the penalty stage of trials, as well.

It shouldn't be too much of a surprise that AAUW has been actively involved in paving the way for this legislative success. Our policy agenda has been actively promoting hate crime prevention, as well as disability education for years. The

work we do on bullying and sexual harassment, while not necessarily hate crimes themselves, is intended to prevent any such escalation.

So why was I taken aback that I learned of the passage of the Matthew Shepard Act not from the New York Times web site or my favorite blogs, but from an AAUW press release? They had the scoop, for at least a half an hour – because *they were there*. They have been collaborating for years with over 100 organizations to effect this legislative change.

To me, it's one of the great things about being member of this organization on the national level: we are there on so many important issues.


That and having an acronym that no one can pronounce: "Awwwww?"

Health Care Reform

Why Should Women Care?

There is no shortage of information available in the newspapers, online, or in media sources about what should or should not be done to "fix" the health care system in this county. I hope you have educated yourself on the issues, the proposals, and the facts. The facts include some important data on how the lack of equitable health care affects women. AAUW's 2009-

Some of the information on the AAUW Webpage was surprising to me. I knew women made less money than men, and that they often worked in jobs that did not include health coverage, but I was outraged to find that women can be asked to pay more for health coverage than men, and are more often denied coverage for preexisting conditions. In an October 8 front page article in the *Leader Telegram*, my cousin was interviewed on the difficulty that many farm families face in getting health insurance. She stated that in her search for affordable health care for her family, the fact that she had breasts and a uterus priced many policies out of their range. An additional factor made the problem even more difficult: a spot on a mammogram marred her medical history, even though the final outcome of the test was OK. Companies are hesitant to sell her, and many women, insurance at any price.

Keep an eye on what happens, as health care legislation is shaped and passed into law. See if the bills include these priorities from the AAUW webpage:

- **End the practice of "gender rating"**: Gender rating is the process by which insurance companies charge men and women different premiums for individually-purchased health care plans.
- Require coverage of women's reproductive health services: AAUW's 2009-2011 Public Policy Program advocates, "choice in the determination of one's reproductive life...increased access to health care and family planning services including expansion of patients' rights." AAUW has long believed that politicians should not insert themselves into the decision-making process when it comes to reproductive health care, which is a basic element of women's health care overall. As a result, AAUW firmly believes that health care reform legislation should require coverage of women's reproductive health services.
- Ensure access to and coverage of preventive services and care: According to the Centers for Disease Control and Prevention, the two leading causes of death for women in America are heart disease and cancer8 afflictions that can often be prevented if women have access to preventive care services such as screenings, immunizations, and educational material.

I hope to report in 2010 on a better health insurance situation for women and their families.

AAUW – Eau Claire supports Ms. Adventure Girls again!

Branch member Deb Pattee, a faculty member in the Department of Curriculum and Instruction at UW – Eau Claire, heads up this program which supports "under resourced" girls in several local elementary schools. Each girl is partnered with a college student who checks in with her weekly. Discussions focus on issues critical to these girls, including dealing with peer pressure, nutrition and exercise, and bullying.
